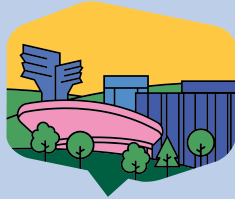

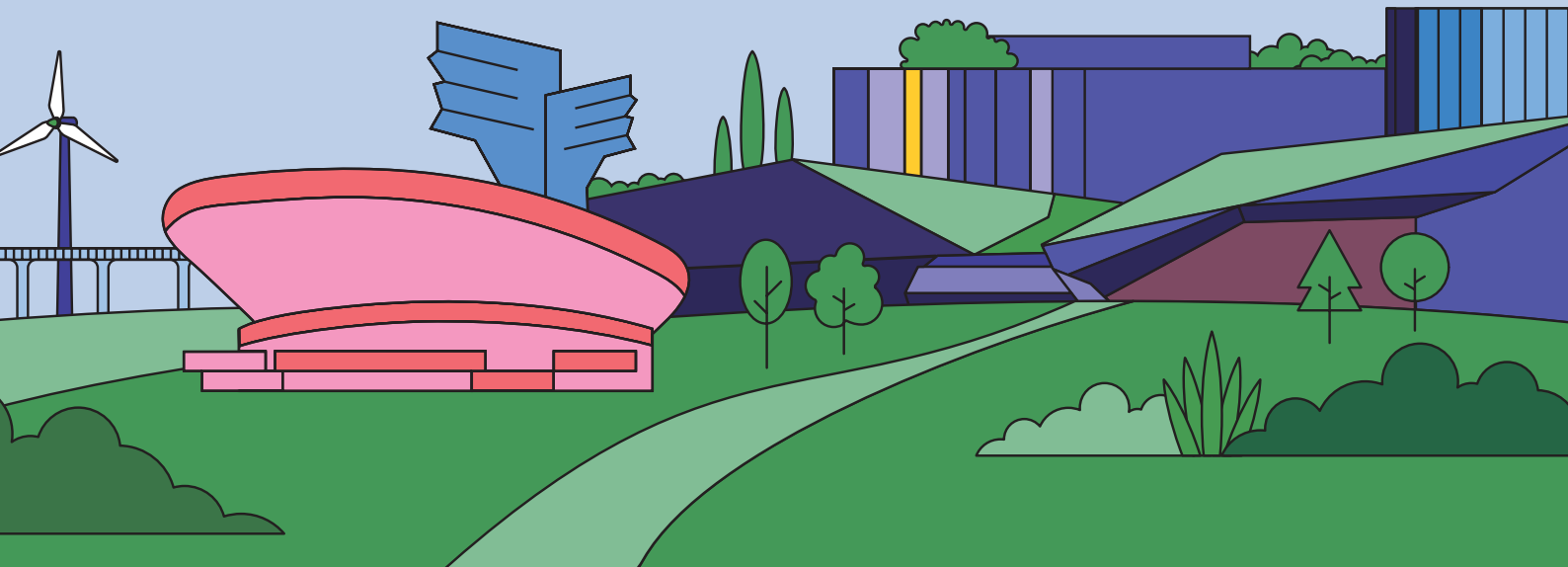

## Forewords



## WUF11 calls for urgent urban action in times of crisis

As the first World Urban Forum to be held in Central and Eastern Europe, it was the right place and the right time to mobilize much needed support for urban crisis response.**

As one of the most inclusive international gatherings on sustainable urbanization, WUF11 welcomed more than 17,000

This report summarizes the more than 450 events, interactive spaces and key achievements of the forum, including the important setting of a new benchmark for accessibility.

There is no better way of deciding on the best course of action than listening to our communities and in particular our young people. WUF11 therefore not only brought together ministers, mayors, governments, urban professionals, academics, members of civil society but, for the first time, a youth council, to debate and develop policy ideas and solutions to enable sustainable urban development and cleaner, more livable cities.

The enthusiasm generated by participants throughout WUF11 was however balanced by warnings that there should be no further delay in taking action. The effects of the climate emergency, diseases, pandemics, the housing crisis and conflict all converge in cities. Time is running out to implement the New Urban Agenda and achieve the Sustainable Development Goals by 2030. We need to act now to ensure that no person and no place is left behind.

We look forward to reporting on shared milestones and commitments post-WUF11. The Declared Actions will carry the sustainable development agenda forward to the twelfth session of the World Urban Forum in Cairo, Egypt in 2024 and beyond.

## A Polish legacy for urban development

**For the first time in history, the World Urban Forum, gathered under the theme: *Transforming our cities for a better urban future*, was held in Central and Eastern Europe – a region that has come a long way from communist rule to democratic governments that are working for the common good.**

From the beginning of the preparatory work, we wanted to organize WUF11 as the most accessible event in its history, in terms of both its organization and programme. We adapted the venue to the needs of people with disabilities, so that everyone could participate in debates. We ensured to an unprecedented extent the use of sign language interpretation and introduced a hybrid formula for the first time. We are proud that the final document of WUF11 - the Katowice Declared Actions - said that "WUF11 has set a new standard of accessibility".

WUF11 showed that it is worth listening to the voices of young people and involving them in the implementation of urban policy. It also emphasized the importance of business sector involvement in the development of cities.

When organizing WUF11, we sought to include the local community in the programme as widely as possible. We did not want to confine discussion about the problems of cities and their inhabitants to within the confines of the conference centre. We wanted the spirit of WUF11 to pervade the urban space, which was made possible by preparing 11 thematic zones throughout Katowice.

Like every host of the World Urban Forum, we wanted to leave a clear legacy after WUF11. A major element of the Polish contribution to the heritage of WUF11 is the "Action Plan for Cities", which aims to help cities develop in line with the UN Sustainable Development Goals and the recommendations of the New Urban Agenda. Another important element is the publication of good practices to ensure equal participation of people with special needs in international events.

**In shaping the future development of cities, we will follow the Katowice Declared Actions. It is time to move on to concrete action.**

In preparing for WUF11, many challenges had to be dealt with, such as struggling with restrictions made necessary by COVID-19, and the war in Ukraine and the consequent, ongoing humanitarian crisis. We knew that WUF11 would be different from previous forums as it was the first to be held relatively near to what by all accounts is a brutal conflict.

After two years of the pandemic, we felt that we all needed a global gathering of representatives of the world's cities and its inhabitants to meet and discuss what is most necessary in today's world. This was evidenced by the number of participants: over 17,000 registered people, with nearly 11,000 participating on site in Katowice and approximately 6,000 online.

The World Urban Forum in Katowice was an important step towards a review of the implementation of the New Urban Agenda and an important platform for the exchange of views and opinions on topics related to sustainable urban development. We discussed how to increase the resilience of cities to various types of threats, and how to make them more open to the needs of people with disabilities.

In the context of the war in Ukraine, we discussed how to rebuild cities destroyed by conflict and stricken by disasters such as earthquakes. One element of the Polish contribution to the programme was a block of events devoted to the European dimension of sustainable urbanization and the just transformation of cities.



## Katowice's proud contribution to sustainable urban development

**Katowice serves as a model example of dynamic transformation from an industrial region into a modern metropolis of two million people. The city has focused on revitalization, the development of culture, business and the creation of new recreational areas.**

The metamorphosis of Katowice was noticed by UNESCO, which in 2015 awarded us the title of Creative City of music. All this has given our city the potential to organize the largest global events.

The transformation of our city perfectly fits UN-Habitat's mission, although it is worth emphasizing that transformation is never a finished process, just like urban policy, something which was discussed during WUF11. There are still new challenges that need to be responded to, which should always be done in a manner appropriate to the local context, because there are no ready-made patterns and schemes that any urban area at any time. In the case of Katowice, change management has become part of our DNA, our urban nature.

The attraction that enjoys the greatest interest at every World Urban Forum is the Urban Expo, an exhibition space where countries, cities, international and non-governmental organizations and companies present ideas and initiatives. In Katowice there were 89 exhibitors from 41 countries from all regions of the world exhibiting across 8,000 square metres, including the US, Germany, France, Mexico, South Korea, Indonesia, Kenya and Thailand. Half of the exhibitors came from outside Europe.

During WUF11, learning and entertainment went hand-in-hand. When each day's discussions and speeches at the International Congress Centre ended, WUF11 participants were able to explore the 11 thematic zones in central

Katowice, formed under the banner of "WUF in the City". A total of 55 events promoted good practice in sustainable urban management and creating livable spaces, with no shortage of good music, cinema and workshops, all free and readily available.

During WUF11 an "Action Plan for Cities. Model Locality" was agreed by 104 Polish cities as a sign of their commitment to sustainable development. The long-term goal of the document is education in the field of sustainable urban policy and initiating actions that change cities into green, accessible and productive places.

## Executive Summary

The World Urban Forum (WUF) was established by the United Nations in 2001 to examine one of the most pressing issues facing the world: rapid urbanization and its impact on communities, cities, economies and climate change. Over the past two decades, WUF has evolved into the premier global conference on sustainable urbanization. Convened by the United Nations Human Settlements Programme (UN-Habitat), the forum is a unique non-legislative platform and one of the most inclusive international gatherings on urban issues.

The eleventh session of the World Urban Forum (WUF11), held from 26 to 30 June 2022, was co-organized by the Polish Ministry of Development Funds and Regional Policy, the Municipal Office of Katowice and convened by UN-Habitat. The forum took place at the International Congress Centre in Katowice, Poland.

Inhabited by more than two million people, the city of Katowice is one of the biggest business centres in Poland and the largest city of the Upper Silesia and Zagłębie Metropolis. Katowice was the first city in Central and Eastern Europe to host the Forum, and the city constitutes a global example of how integrated planning and the establishment of a new economy based on culture, services and creativity continue to attract financing, while making progress towards achieving the Sustainable Development Goals (SDGs).

WUF11 exceeded expectations with more than 17,000 attendees from 158 countries. In the five days of the Forum, more than 450 high-quality knowledge exchanges took place in the form of assemblies, dialogues, round-table discussions and special sessions. There were also unique stakeholder-led events at the Urban Expo, UN-Habitat priority programmes showcased at the UN-Habitat Arena, and 11 urban zones organized throughout the city. The WUF legacy initiatives were presented in various WUF11 spaces, highlighting the transformative impact and host cities of the link between WUF, UN-Habitat programmes and partners.

With strong participation from stakeholders, the forum continues to mobilize a wide range of participants representing national, local and regional governments, parliamentarians, civil society, women, older persons, children and youth, people with disabilities, grassroots groups, indigenous peoples, local communities, the private sector, foundations and philanthropic organizations, academia, professionals and other stakeholders of the New Urban Agenda (NUA).

The theme of the forum, Transforming Our Cities for a Better Urban Future, sought to strengthen relationships and develop action and policy to improve urban environments, in the context of achieving SDG 11 – making cities inclusive, safe, resilient and sustainable. Since adoption of the NUA in 2016, the World Urban Forum has provided an opportunity to advocate for and track the progress of local action towards achieving the SDGs.

Over the past decade, natural hazards and man-made disasters have become increasingly urban. Recent shocks, such as the massive disruption of the COVID-19 pandemic, rising inequality and

environmental degradation, are stretching the social contract to breaking point. Their devastating impact on cities is disproportionately felt by the most vulnerable, leaving some people and places behind.

Now, more than ever, we need to build capacity for more effective urban crisis prevention, response and recovery, and to empower mayors to be in the driver's seat as both first responders and visionaries who can accelerate not just recovery but transformation towards a better urban future. WUF11 introduced the first Urban Crises Track, curating over 40 events that allowed a broad sharing of knowledge and best practices.

**The forum WUF11 was proud to establish a new benchmark for inclusivity and accessibility.**

**The WUF11 was 100% accessible to people with physical and hearing disabilities. The forum offered hybrid (in-person and online) participation in most sessions and discussion events, including the opening and closing sessions. It provided full interpretation in all six official United Nations languages, as well as in Polish and Ukrainian (six events).**



**In-person and online participation**



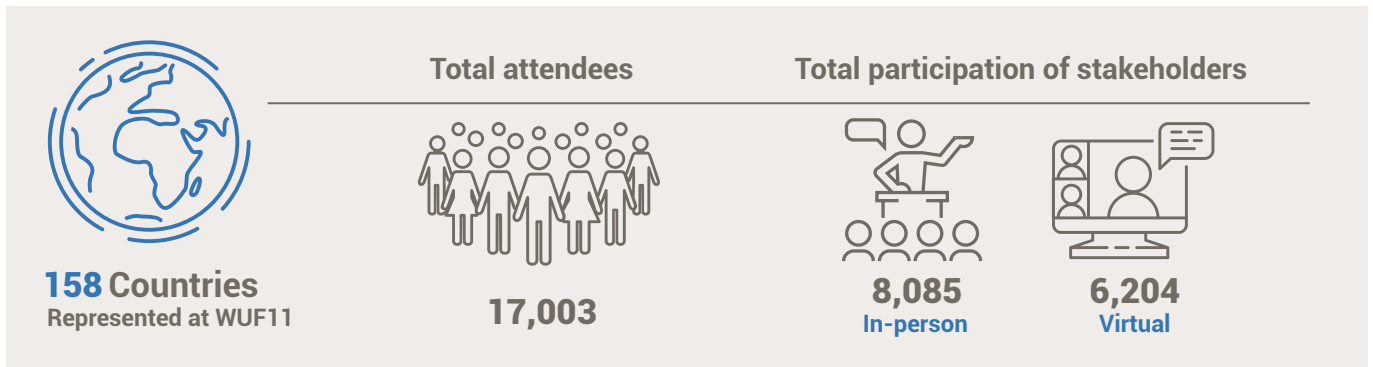

Information was also provided in both the international and Polish sign languages. Communication Access Realtime Translation (CART) speech transcription and numerous other mechanisms provided improved access for people with disabilities. These options demonstrated that transformative action to ensure accessibility for all through universal design is possible in the built environment.

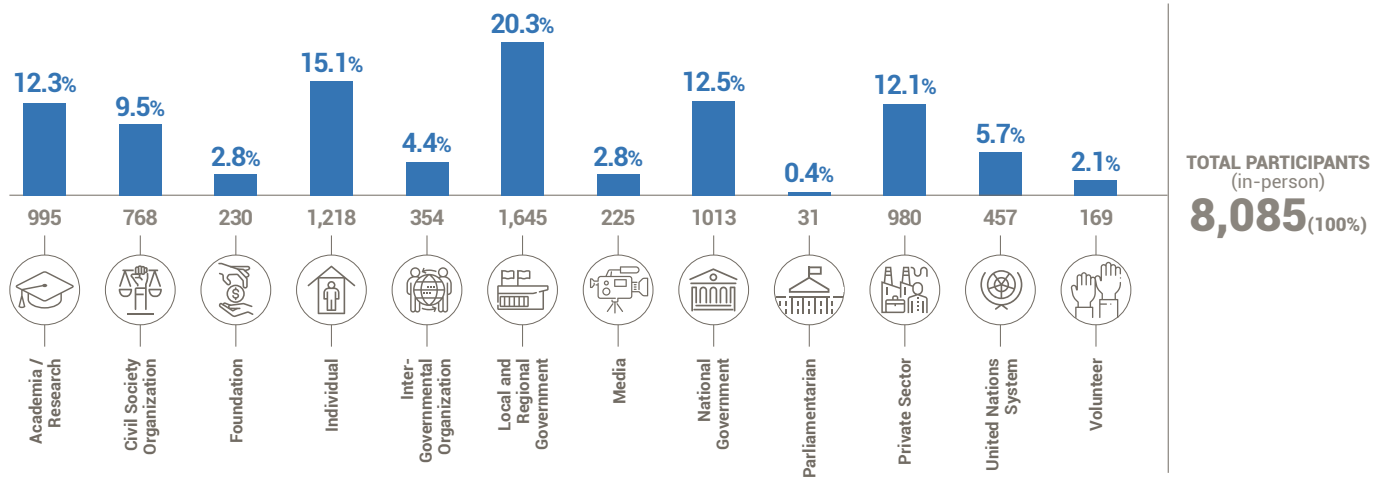
Overall gender parity was achieved in terms of participation, with 47 per cent of participants being women and 53 percent men. The Executive Director of UN-Habitat and the Government of Poland ensured panel gender parity at WUF11, with women representing 52 per cent of the more than 600 speakers at the main sessions. Regionally, in-person representation was led by Europe with 68 percent of participants, followed by Asia at 12.3 percent and Africa 10.8 percent. Local and regional governments were the most represented at 20.3 percent with national governments taking the third at 12.5 percent after individual attendees with 15.1 percent.

The World Urban Forum will continue to call for action and mobilization and track progress on the Katowice Declared Actions, which consist of voluntary actions and commitments made by participants to support implementation of the New Urban Agenda. The goal is to ensure that those actions and commitments are realized, and that the most positive results possible are delivered to the communities that need them most in the run-up to the twelfth session of the Forum, to be held in Cairo, Egypt in 2024.

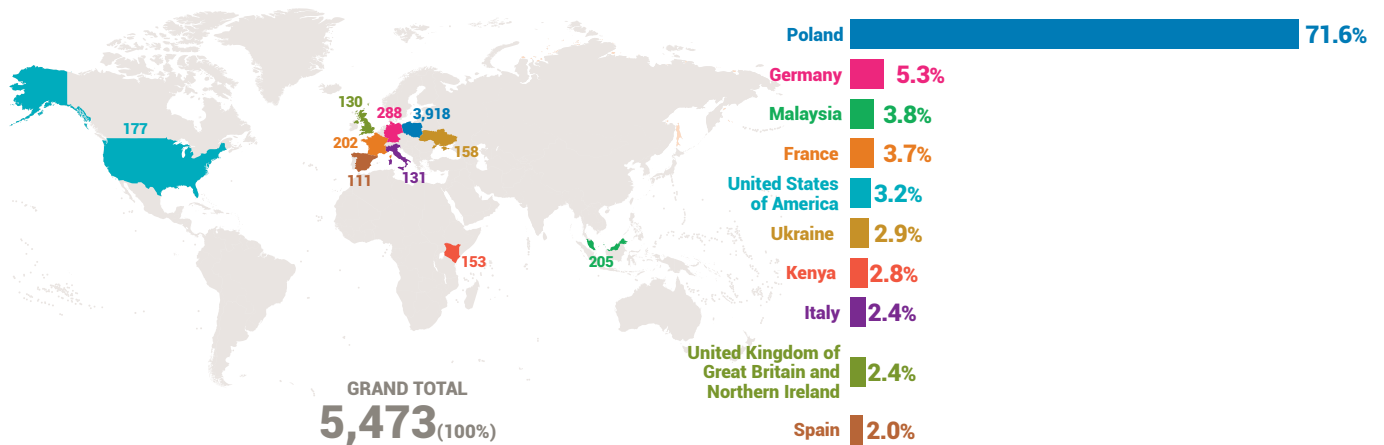
# WUF11 in Numbers



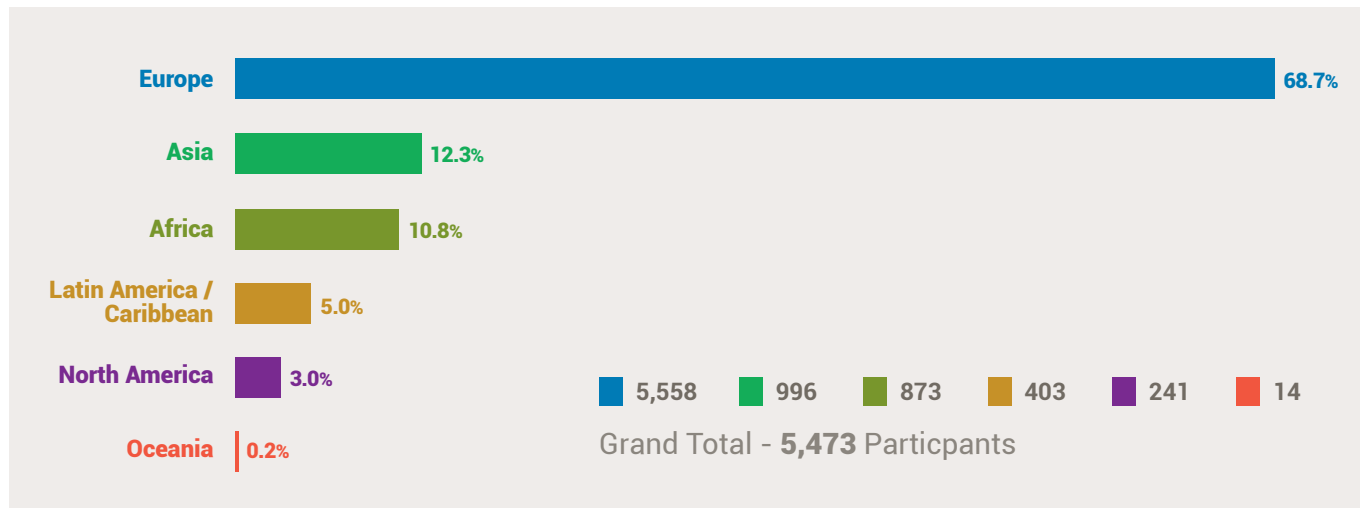
## In-person participation by Partner Type



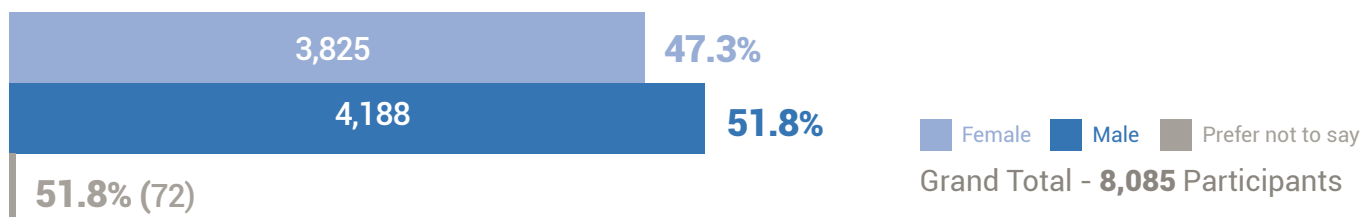
## In-person participation by Top 10 countries



## In-person participation by Top 10 countries

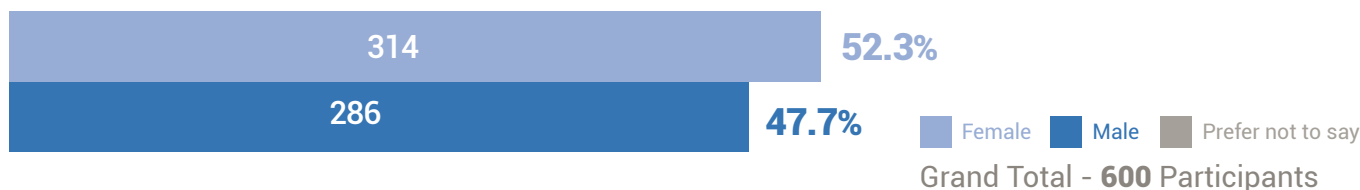


## In-person participation by Gender

## Number and type of events



### Grand Total - 456 Events

- In addition to the official WUF11 events, **28 WUF in the City events** took place during the Forum week within the City of Katowice in 11 zones created for such activities.
- The host country hosted in parallel to the official WUF11 programme **“European Track events” with a total of 17 events** taking place during the week.
- WUF11 for the first time introduced an **Urban Crises Track, curating over 40 events** that allow a broad sharing of knowledge and best practices.

- The **Urban Expo had 89 exhibitors** from 41 countries from all regions of the world setting up their stands on 8,000 square meters of space.
- Over the period leading up to the eleventh session of the World Urban Forum and during the week of the eleventh session of the World Urban Forum, there was a **total media reach of 4.4 billion** across various channels: online, print and broadcast.
- WUF11 had **350 media representatives** registered and 200 attending in person.

## Katowice Declared Actions

**The Katowice Declared Actions consists of voluntary actions and commitments made by participants to support implementation of the New Urban Agenda.**

1

We, the participants of the Eleventh Session of the World Urban Forum, convened by the United Nations Human Settlements Programme (UN-Habitat) hosted by the Government of the Republic of Poland in the City of Katowice and co-organized by UN-Habitat, Poland's Ministry of Development Funds and Regional Policy and the Municipal Office of Katowice, representing national, subnational and local governments, international and regional organizations, parliamentarians, civil society, older persons, children and youth, women, persons with disabilities, grassroots groups, business leaders, indigenous peoples and local communities, professionals, the private sector, foundations and philanthropies, academia, professionals and other relevant stakeholders.

Together, we gathered here in Katowice, Poland, to dialogue on the theme "Transforming our Cities for a Better Urban Future." Now, at the conclusion of this World Urban Forum we declare our voluntary actions and commitments for the next two years and beyond. We call for more international, multi-stakeholder and inter-generational cooperation and collective actions in support of the speedy implementation of the New Urban Agenda and to reposition the New Urban Agenda strategically as a road map for accelerating sustainable development, climate action, and building peace.

We welcome the increased use of Declared Actions from Member States and other relevant stakeholders as set out in the Annex of Declared Actions, committed to by Member States at the United Nations High-Level Meeting (April 2022) on the Implementation of the New Urban Agenda, convened by the President of the General Assembly, and in the Global Stakeholder Declaration (Nairobi, April 2022) and other global fora.

We are concerned by the lack of progress towards the SDGs and the Paris Agreement and call for urgent transformative action. We need to focus on pathways to transformative change and investigate examples of cities that have reached a tipping point and turned the corner by instituting innovative and progressive policies and planning regimes. Urban leaders must move from incrementalism and work to achieve fundamental shifts in urban environments, systems of governance and forms of habitation, in line with human rights treaties. COVID-19 has shown that substantial change is possible in the short term, but the challenge is in delivering long-term and sustainable change.

We need to focus on increasingly imminent urban crises. The climate and biodiversity emergencies, pandemics, violence and conflicts, and other natural and man-made disasters, all converge in cities and surrounding territories. Being prepared for and overcoming these crises becomes a pre-condition to transform towards a better urban future.

We welcome the use of an Urban Crises Track during WUF11 to galvanize the exchange of knowledge and practices between stakeholders in all countries dealing with or affected by conflict and disaster, including from countries newly affected by conflict and disaster, such as Ukraine.

We, the participants of WUF11, reconfirm that culture, as a core component of local identity including heritage, creativity and diversity, is an integral part of the solution to the challenges of urbanization, including urban crises, and to achieving the New Urban Agenda.

We recognize that WUF11 set a new standard of accessibility and reconfirm that accessibility and universal design are an integral part of the solution to the challenges of urbanization, including urban crisis, and constitutes the agent of transformative action for a more equitable urban future.

We encourage all development actors gathered in Katowice to mobilize their respective capacities in this Decade of Action. We will continue to call for actions and mobilization and track progress through a monitoring and reporting mechanism. We make an urgent appeal to all governments to better fund UN-Habitat to ensure that its elevated mandate is met by enhanced resources and capacity of UN-Habitat.

We call upon all stakeholders to continue submitting their Declared Actions for the next 30 days (till 31 July 2022) as part of the World Urban Forum 11 through the Urban Agenda Platform, highlighting the transformative nature of their commitments. The current list is as such only tentative and the Urban Agenda Platform should contain all detailed Declared Actions, aligned with the thematic areas that emerged from the High-Level Meeting on the Implementation of the New Urban Agenda in New York. We encourage participants to further develop their Declared Actions to make them measurable.

We thank the Government of Poland and the City of Katowice, and UN-Habitat for convening the Forum. And we commit to providing continuous cooperation to the next hosts, the Government of Egypt and the City of Cairo.

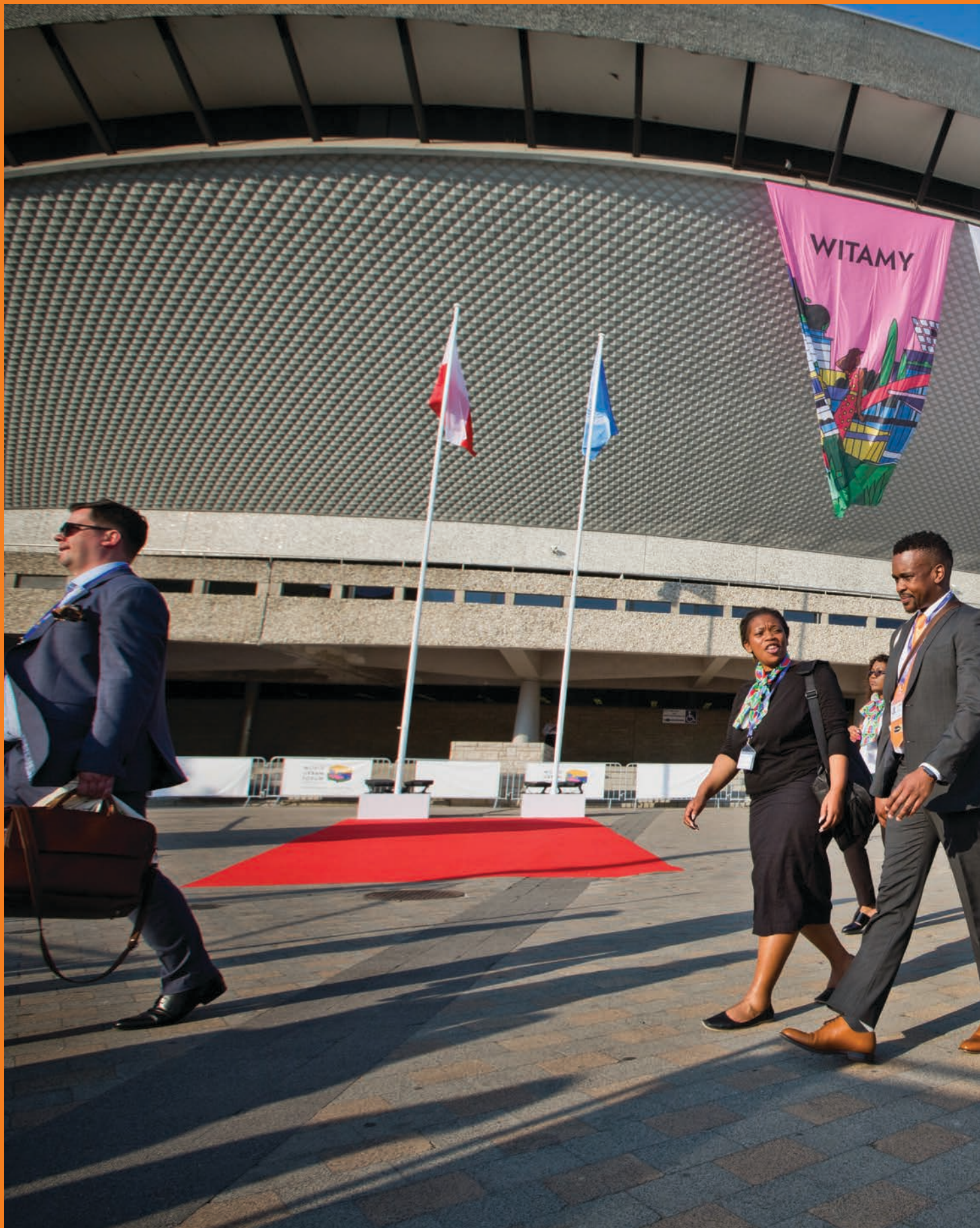

## WUF11 Overview



# Main Events

## Dialogues

The dialogues were high profile events that set the agenda for policy and action throughout the forum and beyond. They provided a platform for global thinkers, practitioners, and decision makers to share insights on the overall theme of the forum.

### Key Insights and Transformative Ideas

#### Extraordinary Dialogue on Urban Crisis Response and Recovery

As crises intersect and converge in cities it is crucial to give importance to local governments and their local knowledge when addressing crises.

- Cities need data to understand the impact of crises, to be better suited to plan responses, and to use the opportunity of crisis to innovate and improve processes and capacities.
- An inclusion lens is needed so that internally displaced persons, migrants, and refugees are considered during crisis responses.
- To overcome the trauma of crises it is important to tap into the creative and imaginative capacity of young people to take positive action and shape a different future.

- Cities that adopt a rights-based approach to human settlements development can create inclusive, lively, and prosperous societies.

#### Dialogue 2: Building Resilience for Sustainable Urban Futures

The dialogue emphasized the need to move away from linear resilience approaches and to focus on urban systems, and using urban resilience, equity and social justice to create a foundation for sustainable development

- Advocacy and networking investment in a cultural and behavioral shift are needed to adopt more sustainable lifestyles.
- Regional plans for risk management, recovery, and social reconstruction can acquire a gendered perspective.

#### Dialogue 3: Future Urban Economy and Finance

The future of urban finance will be a combination of a different set of financial products and instruments such as concessional loans to the state with sovereign guarantees, social bonds, green bonds, equity and guarantees; bringing urbanization at the core of the finance policy value chain.

- The use of social bonds linked to positive social outcomes and the SDGs can be met with partnerships between public and private sector.
- Local governments must strengthen the mobilization of domestic resources, and be ready to institute prudent, functional and robust fiscal policies and mechanisms to ensure greater and direct access to affordable credit and loans.

#### Dialogue 1: Equitable Urban Futures

The vision for an equitable urban future is hindered by persisting poverty, discrimination, violence, and exclusion. Inequity in rights and opportunities to live a peaceful, safe and dignified life is perpetuating multiple forms of marginalization.

- Inequalities take various forms. Crises and conflicts rapidly exacerbate and create new inequalities – access to vaccines, technology, education and income opportunities, environmental and climate inequalities, and refugee flows.

### Dialogue 4: Integrated Governance in Spatial Planning for a More Just, Green and Healthy Urban Future

The interplay between urban planning and multi-level governance in addressing spatial inequality, climate change, and urban health in the post-pandemic context was highlighted.

- Underscore the importance to increase participation of multiple stakeholders, including the private sector and civil society, as well as vertical and horizontal integration in spatial planning processes.
- Multi-level governance and spatial planning allow cities to make critical progress on several SDGs, simultaneously impacting areas of poverty and social exclusion, food systems, health, territorial cohesion, local climate action, migration, integrated digital transformation strategies, improved private sector involvement and enhanced local employment opportunities.

### Dialogue 5: Transforming Cities through Innovative Solutions and Technologies

- New partnership approaches are required to respond to the urban challenges that bring together government, business, entrepreneurs, academia, and communities to co-create solutions with real impact on quality of life.
- Cities need to define the policies and regulations to ensure that technology works for people towards the achievement of the New Urban Agenda.

### Dialogue 6: Greener Urban Futures

A stronger system for multilevel climate action is needed to achieve the Paris Agreement and the SDGs, including clearer commitments by national governments to support cities in the development and implementation of climate change and resilience strategies. This is particularly important in small island developing states and least developed countries where inequity has amplified vulnerabilities.

- Existing barriers for access to climate finance need to be broken down; there is a need to rethink what it means to develop a bankable project and to better frame issues related to financial returns on resilience building.
- Effective and inclusive communication is critical for citizens to understand and be included in the conversation.

## Assemblies

Created to give voice to key stakeholder groups from broader segments of society, to contribute ideas or language to the WUF11 Declared Actions, which will provide a roadmap for cities to achieve the Sustainable Development Goals. The assemblies were instrumental to support an inclusive and participatory decision-making process for a scaled-up implementation of the New Urban Agenda.

### Key Insights and Transformative Ideas

#### Grassroots Assembly

Inclusive and equitable spaces must be created for a direct and solid sensitization, mobilization and engagement of local actors and community leaders, at all levels, placing them as equal partners in the planning, design, implementation and monitoring phases of all slum upgrading initiatives.

- Governments and other development partners need to use locally collected data for better evidence-based decision making.

#### Children and Youth Assembly

- To ensure that access to basic needs, including mental health and well-being, should not be limited based on gender, sexual orientation, age, race, or socio-economic status.
- To prioritize employment opportunities such as green jobs for youth and provide capacity building to strengthen their job skills.
- Youth and children ask the governments and local authorities to take urgent steps to ensure that their voices are heard and actions are taken seriously. As young and responsible citizens who have already been working hard to improve cities, they commit to continue to be part of the implementation of the action points outlined in the "DeclarACTION".

#### World Assembly of Local and Regional Governments

The successful implementation of the New Urban Agenda requires a multi-level, multi-stakeholder governance approach.

- Regarding cities as caring spaces is paramount to safeguard local communities and ensure that no one is left behind.
- The importance of local and regional governments as caring actors, which must have the capacity to deliver local services, and care for all its people, especially focusing on the most vulnerable: women, youth, elderly, the LGBTIQ+ community, migrants, IDPs and refugees.

## Women's Assembly

Securing women's land rights and securing land rights is a fundamental concept in the realization of adequate housing in cities and human settlements.

→ Political participation and representation of women needs to be encouraged and supported. There is a need to emphasize the importance of having women leaders because they can broaden the range of consideration and needs for other vulnerable groups.

→ The importance of assessing global issues such as climate change, war, refugee crises and, housing problems through a gendered lens.

## Business Assembly

While businesses often embrace societal impact and environmental sustainability in their work, there is a need for incentives.

→ For businesses to take a more effective role in accelerating the achievement of SDGs and in responding to crises there

is a need for improved frameworks for engaging businesses in urban development and better business models for ensuring societal impacts and environmental sustainability.

→ Businesses would benefit from more effective finance flows to businesses at local levels, effective de-risking strategies and a guarantee facility for business engagement with cities in crisis.

## Roundtables

These action-oriented sessions enabled peers to exchange views on key urban issues, on occasions via closed door events, as well as open ones to the public. Partner constituencies were invited to roundtable events to identify areas of consensus and ways to move forward on identified emerging issues and global trends.

### Key Insights and Transformative Ideas

#### Local and Regional Governments Roundtable

- Local and regional governments have a vital role not only as implementors of development agendas but also in safeguarding local communities. Therefore, cities need to have a permanent and ongoing voice in international forums, as active subjects that can enable change.
- National governments must see local and regional governments as vehicles to achieve global goals, and regard decentralized cooperation as a win-win process. This includes strengthening local finance, technical guidance and policy support.
- Not all cities, and neighborhoods within cities, are equal, which therefore requires contextual and targeted policies.

#### Business and Industries Roundtable

- The roundtable was seen as a comprehensive and sincere discussion on the cooperation of public and private sector in order to implement SDGs.
- Investments required to fulfill the New Urban Agenda, the Paris Agreement and the SDGs have to be fulfilled by the cities and with the involvement of the business community and private capital.
- A proper legal framework is necessary to attract businesses in addition to involvement of all stakeholders with transparency, sanctity, security assured from and to the private sector.

#### National Urban Policies in a Changing World Roundtable – led by Poland

- The roundtable highlighted the strength of National Urban Policies (NUPs) in fostering intersectoral and inter-regional coordination. During the meeting the Poland's new NUP was presented.
- Important points included data in effective decision-making; the connection between digitization and resilience, diversification of energy sources, adaptation to climate change and energy sovereignty; the need for affordable, sustainable, and secure homes; and sustainable, efficient, and safe transportation systems were discussed among relevant ministers representing Czech Republic, Germany, Poland, the Netherlands and Sweden.

- The session concluded with the need to break through silos and foster cross-sectoral collaboration on urban development.

#### Parliamentarians Roundtable

- Parliamentarians can provide accountability, oversight, support and legislative backing to delivering the NUA and SDGs, including voluntary urban reporting, or localizing the SDGs.
- There are also a plethora of policy areas and issues: from developing legal frameworks, addressing the needs of marginalized groups, from urban-rural linkages, employment, migration, municipal services including health and education, private sector development, social inclusion, and business and taxation, where parliamentarians are well suited to provide unique perspectives.

### Persons with Disabilities Roundtable

- There is a need to leverage the lessons learned from COVID-19 and ensure national and local governments work together, making sure everyone benefits from inclusive and universal design.
- Without data it is impossible to design features that are accessible for all. Therefore, the participation of persons with disabilities in urban development and decision making should be meaningful and encouraged.
- Good design practice should support independent living, promote good mental health, and make one feel safe and welcome in cities.

### One UN Roundtable

- The session recommends enhanced UN urban programming at the country level, and collaboration among entities to leverage integration and to match progress made at the global level.
- The session recommended the development of urban approaches to key UN mandates such as urban health or urban food systems, with the development of tools relevant for programming in collaboration with country level offices.
- Stepping up of support and capacity development will require significant new resources for UN-Habitat and other UN entities.

### Women's Roundtable

Governments need to ensure that women's participation in policies and programs to achieve gender-based perspectives. Ensuring women rights, such as the right to land, is a step towards economic empowerment, political engagement, and addressing inequalities.

### Older Persons Roundtable

- Understand the ageing of societies and the process of ageing, recognizing its universality and heterogeneity and the role that local governments have to play with specific age-appropriate characteristics.
- Support the human rights of older persons to protect their dignity and quality of life including through advocacy, protocols, acknowledgement of contributions, fighting pervasive misperceptions and including inclusive practices to serve vulnerable or excluded older groups, such as older or abused women, homeless, displaced persons and refugees.
- All cities must be good places to age in place, as age-friendly communities work for all ages.

### Ministerial Roundtable

- The urgency of accelerating the realization of the SDGs was highlighted with 90 months left before 2030. Thus, an urgent appeal was raised to all governments represented at the Ministerial Roundtable to better fund UN-Habitat to ensure that its mandate is met by enhanced resources and capacity by member states.
- Argentina, Cameroon, Ethiopia, Sweden, the United Kingdom, Iran, China, and Thailand among other countries called for more international cooperation and collective actions for achieving the global agenda, including the New Urban Agenda.

- The need to collect gender-disaggregated, community-led data and to train communities to analyze and use the data for implementing gender responsive policies was highlighted.
- Likewise, the need to foster women-led saving schemes paves the way for women to formalized saving schemes and create organized networks.
- Harnessing the role of customary and traditional leaders as champions while creating dialogue spaces to walk with them and not leave them behind is a great strategy to secure women's voices and decision-making power. Communities that care for women's rights, are communities that will have a just and inclusive future.

### Academia Roundtable

There is a shift in the way that academia engages in transformation in cities by linking research to current issues.

- The discussion reinforced the importance of research and related actions going beyond gap analysis and recommendations, to the need for solutions.
- Research and technology should be at the center of innovations produced and transferred by academia to support impact at the city level.

### Professionals Roundtable

- There is a need for new forms of connecting the planning professionals, municipal stakeholders, businesses and citizens if the SDGs are to be achieved. Spaces that allow exchange and trust building between major stakeholders should be encouraged.
- Current governance systems have been failing. The Global Roadmap to Recovery's key message presents a clear need for a fundamental shift in professional practice and policy. One way to address this is through the fundamental repositioning of landscape as the relationship people have with their territories.

- The ownership of the projects must lie with the community, therefore institutional engagements with communities should be mandatory. As local communities are horizontal actors and public offices are vertical actors, synergy of these two will initiate a place-based approach.

### Foundations and Philanthropies Roundtable

The session highlighted opportunities in long-term unrestrictive funding with foundation, in incorporating a value-based grantmaking process to communities, and bonds which provide liquidity to partner with microfinance institutions and banks.

- As an example, UN-Habitat's and Block by Block partnership has encouraged young people to aspire to design and implement the real public space projects on the ground within their localities.
- Foundations and philanthropies should think more long term and around systems. They should reimagine these systems with communities in mind and help build them so that they are more efficient in advancing equity and justice.

### Children and Youth Roundtable

Young people are a key resource in raising awareness of urban crises and climate change impacts, as well as in the co-creation of solutions.

- There is an urgency to focus on the health and wellbeing of young people, and providing them with safe public spaces and opportunities for education and training, as well as support mechanisms including psychosocial support and the creation of safe spaces.
- Strong institutional frameworks that are devoid of political interference are necessary for sustained meaningful participation of young people, regardless of transitions in governing regimes.

### Civil Society and Grassroots Organizations Roundtable

- The event emphasized the process of co-creation, between the state and civil society, as a powerful catalyst for present and future development initiatives.
- Key partners to be accountable to the communities engaged in the participatory process. It is crucial to create commissions. CSOs and grassroots organizations should be considered as co-authors of all projects.
- Women, who have been left out of development initiatives for too long, need to be encouraged to build back their confidence and come together as powerful associations with innovative solutions for urban development.
- Resources are needed to engage CSOs and grassroots organizations, such as scholarships, education and capacity building programs and technical training. To have psychological and emotional effects and needs considered in all initiatives.

### Trade Union and Workers Roundtable

- Local, regional and national governments urgently need to involve workers and unions in their plans for climate mitigation and adaptation, and to include labour issues in urban policies.
- The need to support and encourage the de-privatization and de-commodification of life-saving public services, and instead promote municipalization was highlighted.
- Ensuring decent work as per the ILO framework in all urban public services and industrial sectors and to deliver on the NUA commitment on the progressive formalization of informal to formal employment, including a robust social protection system.

## Special Sessions

Special sessions are convened to explore the challenges and opportunities presented by topics of global importance, and their relevance to the host city and geographical region.

### Key Insights and Transformative Ideas

#### Special Session: Urban Recovery Frameworks

Governments can be supported by globally adopted urban recovery frameworks during crises as a way to help overcome the humanitarian – development divide and empower local governments.

- Financing instruments backed by mutually supportive multi-governance mechanisms are key to drive urban recovery, including more transparent national to local fiscal transfers, strategies to de-risk financing and investments, and to address the root causes of crises.
- Anchoring urban recovery in culture and identities has the potential to leverage and sustain action at a larger scale.

#### Special Session: Urban Data and Circular Economy

The global urban monitoring framework demonstrated that the scaling up of data is required.

- The circular economy is well understood among development actors as a concept, however adoption remains low due to a lack of consumer understanding on the benefits, a lack of funding and incentives, and a lack of deterrent policies for wasteful and linear value chains.
- There is a need to invest in government-led regulations regarding reuse and repurposing of all waste streams.

#### Poland Special Session: Rebuilding Communities and Neighbourhoods After War and Natural Disasters

- The session focused on the institutional dimension of the rebuilding process, highlighting the perspective of humanitarian and development actors, as well as brought civil society organisations and youth to discuss rebuilding and recovery not in terms of building infrastructure, but addressing the needs of people in areas affected by conflict or natural disasters.
- This event highlighted inter alia the need for an ambitious rebuilding of Ukraine, with financing mechanisms and a clear emphasis on building back better, which means creating

an environment that is better for the climate, more inclusive and more resilient.

- The focus should be on three dimensions: peace and security, humanitarian and development.
- Poland's response to the migration from Ukraine in the face of war can be viewed as a success story and good practices can be replicated. The call is to also remember other conflicts happening across the globe which are affecting millions of city dwellers.

### Special Session: National Urban Forums - Strategic Platforms for Implementing the SDGs and the New Urban Agenda

NUFs as multi-stakeholders platforms can support sustainable urban development processes and debates at the country level, as well as discourse on best practices.

- NUFs can become tools for knowledge generation and exchange to grow stakeholder engagement and increase awareness on urban development, connecting local, regional and national governments, as well as civil society and non-government partners.
- NUFs are also key platforms for accelerating the localization of the SDGs when well-articulated between levels of government.

### Special Session: Delivering Affordable Housing Across Continents

Stakeholders should identify priorities for the realization of the SDG Goal 11.1 to ensure access for all to adequate, safe and affordable housing.

- The event highlighted the need to promote more technical and high-level forums on housing and urban development.
- Addressing housing challenges is central to achieving the New Urban Agenda and SDG 11.

### Special Session: Tackling Urban Health Challenges in a Changing World

The pandemic exposed inequalities linked to health and urban spaces.

- Health-related criteria should be included in the design phase of urban spaces considering walkability, greening, quality of water, mobility and road safety. This should be guided by health-related data.
- Tackling urban health can have a mitigating effect on diseases by increasing physical mobility, improving mental health and prevent premature deaths.

### Special Session: The City We Need Now!

A permanent dialogue can be fostered for the Urban Thinkers Campus mechanism as a platform for increased synergies and concrete initiatives.

- The City We Need Now! was an event that guided partners as a framework of actionable principles and priority actions. It also served to showcase the City We Need Now! manifesto that will inspire further transformative actions.

### Special Session: Climate Adaptation and Nature-Based Solutions for Resilient Cities

Climate action efforts in cities focus predominantly on mitigation, only 21% of overall climate finance is channeled to adaptation and, of that, only 10% of climate fund investments reach the local level. There is a need to understand opportunities for financing.

- Key barriers to nature-based solutions include information and technology, the need for bankable projects, human resources and fiscal capacity.
- Co-benefits may include recreation and mitigation benefits in addition to adaptation.

### Special Session: Prerequisites for Productive Investment in Infrastructure and Sustainable Urban Development

Synergy is important in enabling more effective and productive partnerships in urban infrastructure and services. Neither intergovernmental transfers, internally generated revenue nor private investment can solve the financing problems.

→ Increasingly, it is essential for cities to facilitate diverse economic opportunities taking into consideration complementarity, as well as an enabling environment to harness sustainable and competitive finance and partnerships.

### Special Session: Localizing the SDGs

The 2030 Agenda remains the global framework of reference for sustainable development and recovery planning. The agenda clearly places cities and territories at the center of development, while identifying collaboration across spheres of government.

- The achievement of the SDGs depends largely on action at local level. However, the local level cannot act alone. In this context, it was argued that the role of the national government becomes stronger in delivering SDG localization via the multidimensional support to the local and regional governments.
- The importance of a whole-of-society approach – particularly in engaging the youth– was reiterated. The panelists also emphasized the importance of addressing the lack of funding and the closure of data gaps.

### Special Session: Shaping Equitable Urban Futures

Discussions focused on factors that are enabling cities to introduce transformative strategies, and the barriers holding them back from going further.

- Discussions centered around recognizing care as a human right, to integrating social services, for refugees for instance, broadly into the local levels, as well as social housing provision and the importance of using multiple methods to adapt to the community's needs.
- Challenges that can hinder progress on international agendas often include lack of decentralization and finance.

### Special Session: Accelerating Post COVID-19 Recovery, Social Inclusion and Urban Inequality Reduction in Communities

The post pandemic period is an opportunity to strengthen resilience and sustainable development in cities and communities of all sizes.

- The event highlighted the need for a human rights-based approach and strengthening equality, data collection and analysis with an inclusion lens.

→ Comprehensive long-term urban policies are needed in coordination with normative frameworks that prioritizes vulnerable populations and allows collaboration between the different levels of government, as well as stronger multilateralism and cooperation.

### Special Session: People-Centered and Green Technology

The event discussed sustainable housing and climate change, innovation and connected communities.

- The importance of multi-stakeholder consultation and citizen participation was emphasized. Partnerships need to be created between cities, the private sector, various levels of governments, and all stakeholders.
- Digital maturity assessments are required to understand the position of cities in terms of digital advancement so that data-driven decisions can be made. It is essential to build the capacity of government staff to ensure that digitalization and smart city projects are effective.

## European Track

*Transforming European Cities: for a Better Europe, for a Better World.*

The block of events dedicated to the European dimension of urbanization in the context of global challenges organized by the Polish Ministry of Development Funds and Regional Policy and the Institute of Urban and Regional Development in cooperation with institutions and organizations shaping urban policies in European countries and cities.

## Urban Expo

The Urban Expo provided a monumental opportunity for governments, UN agencies, businesses, non-government organisations and academic institutions to showcase their solutions and innovations to achieve sustainable urbanization. The Urban Expo is the most popular attraction at every World Urban Forum, and this year's eleventh session in the gleaming Katowice International Congress Centre was likely to be the biggest ever. Exhibitors had the opportunity to showcase their best practice, their cutting-edge technology and their best demonstrations of how cities are the engines of solutions to the challenges of housing, transport, energy and access that stymie inclusive, equitable development.

## Urban Cinema

The UN-Habitat Better Cities Film Festival at WUF believed in the power of storytelling to inspire and empower cities and communities. The Urban Cinema room as a result was a space that fostered civic pride, built community and sparked our collective imagination for a better future.

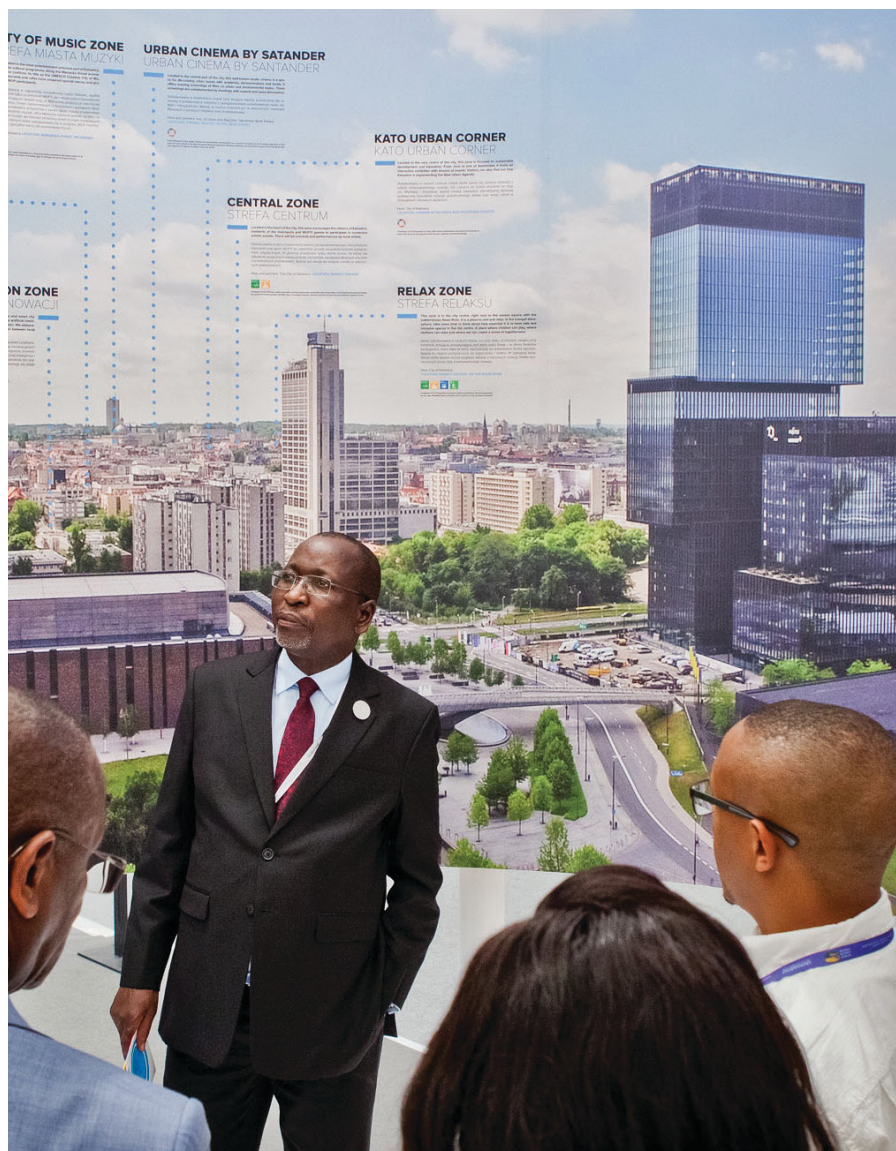
## UN-Habitat Arena

**WUF Legacy**

## WUF Alumni Network

UN Habitat facilitated the formation of the WUF Alumni Network as a vehicle to support UN-Habitat in various endeavours relating to WUF, especially documentation of lessons learned. It was highlighted that WUF has been an amazing journey of two decades. The WUF Alumni Network convened for a working session to review WUF's impact.

The first WUF took place in Nairobi, Kenya in 2002 and has since been held around the world every two years.

## Cities Investment Fair and Project Showcase

### Unlocking Transformative Finance for Cities and Communities

The Cities Investment Fair sought to mobilize financing for sustainable development by connecting project preparation facilities and investors with SDG-aligned projects in emerging and frontier markets. The fair facilitated knowledge sharing among cities and enabled participating local governments to present their priority climate infrastructure projects to an eminent panel

of project preparation facility providers and investors.

The Cities Investment Facility project showcase sought to promote awareness of the value proposition of the Cities Investment Facility to investors, donors, project preparation facilities and local governments by presenting case studies of SDG-aligned projects in emerging and

frontier markets. The project showcase facilitated knowledge sharing among countries and enabled participating local governments to demonstrate how the Cities Investment Facility has helped them to increase the alignment of projects with the Sustainable Development Goals and improve the feasibility and bankability of their projects for investment.

## Summary of Press and Media Coverage



## WUF11 The Hub: Press Conference Centre

Sessions at the WUF11 The HUB: Press Conference Centre brought together urban journalists and media practitioners, organizations and institutions that wanted to share latest news or present important initiatives. Press events were open to all accredited media representatives and participants.

More than 350 media representatives were registered, including around 200 who attended in person. Stories about the World Urban Forum featured in different types of media including online news, blogs and broadcast TV/Radio.

The biggest share of news coverage, 80%, was through online news platforms.

During the period 26–30 June 2022, the week of the Forum, more than 2,000 news items mentioning UN-Habitat were featured in various media channels. Social media platforms such as Twitter showed a 400 per cent spike in items mentioning UN-Habitat, while coverage on online news platforms was up 500 per cent and newspaper coverage up 200 per cent.

In terms of outreach and advocacy, events covered live by United Nations Web TV

streaming (webtv.un.org) received a total of 46,145 views. Considering that United Nations Web TV handled competing United Nations events during the same period, the online audience for the Forum sessions was robust.

Over the period leading up to the eleventh session of the World Urban Forum and during the week of the eleventh session of the World Urban Forum, there was a total media reach of 4.4 billion across various channels: online, print and broadcast.

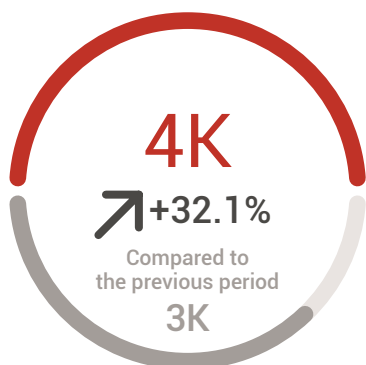

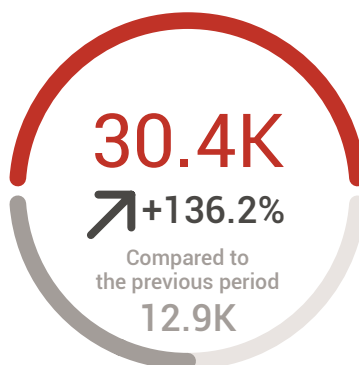

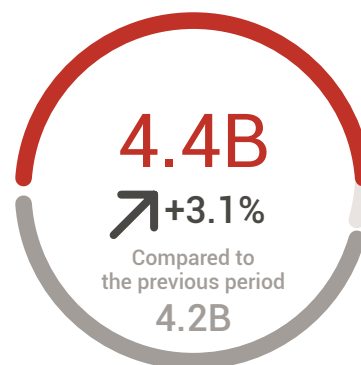

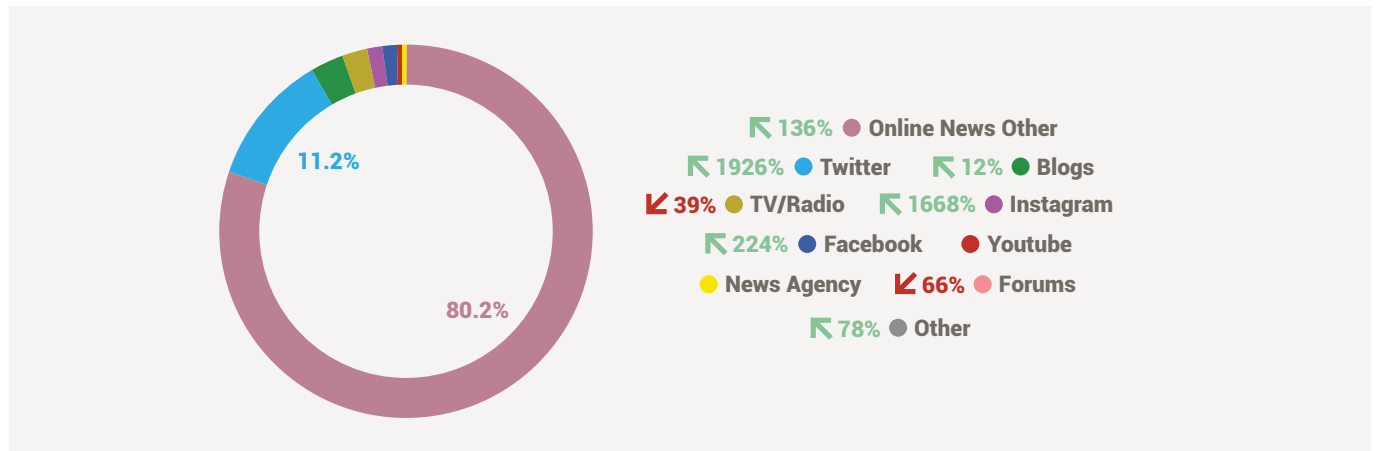
